

# ECLIPTIC ARIES Functions

#### Company Profile

Ability to capture corporate information, branches, individuals, areas of specialism and licencing. Varied by stakeholder type (TPA, MGA, Broker, Insurer, Service Company & Auditor) to capture core corporate information, services, office locations, teams/personnel etc. with self-service options.

The private area between parties to manage ongoing relationships and capture contract information, fee structures, payment terms etc. Ability to create and manage preferred panels of providers based on geography, class of business etc.

#### Due Diligence

Varied by stakeholder type (to supplement the Lloyd's DCOM platform or similar) to meet client requirements. Ability to query, reject or approve each DD element with auto diary for annual attestation and renewal of key documents e.g. D&O/E&O insurance policies. Key documents to be stored & versioned as required.

Create and build DA & TPA contracts, manage templates & assign contract(s) with supporting workflow, reporting & MI dashboards. The ability for stakeholders to approve/accept contract and agree terms. Contracts provide a structure for future validation of policy, risk, claims & performance monitoring.

#### Communication

Email & collaboration tools to better enable close interaction between stakeholders within the platform and capture of key actions, agreements and dates.

Capture/report structured SLAs with alerts/reporting on variances standards. Initiate, schedule & undertake audits via the platform remotely, capture results, scoring, key recommendations (RAG) & actions, diary & escalation and enable resolution between parties.

### Service Level & Audit Tool

#### Performance Dashboards

Dashboards to cover individual stakeholder and contract performance and comparison tools (e.g. league tables) for performance across the client portfolio of stakeholders and contracts.

Analytics tool being developed to delve further into available platform data to provide predictive analytics, CAT assessment based on risk location and to support underwriting and actuarial decisions etc.
